This annual fugitive dust control report has been developed to describe the actions taken by plant personnel or contractors to control CCR fugitive dust, a record of citizen complaints and a summary of any corrective actions taken. The facility routinely sprays water in areas where loose, dry CCR material is present by means of an AARF (Aircraft Rescue and Firefighting) Truck, irrigation system and/or fire hosing.
